REQUIRED ACCESS TESTING FOR ENGLISH LEARNER STUDENTS Thursday, April 8th



EL students will complete the ACCESS test on Thursday, April 8th, 2021. Testing will begin at 10:00am and end at approximately 3:00. The State of Illinois requires all English Learners to take the WIDA ACCESS 2.0. The ACCESS test measures *listening, speaking, reading* and *writing skills.* Assessment results are used to determine continued EL eligibility and placement in future courses.

At this time, the State of Illinois is requiring that all EL students take the ACCESS assessment in person. Students will follow the normal safety protocols upon entering the building. Temperatures will be checked. Masks must be worn correctly over the nose and mouth during the entire testing session and while in the building. All students and staff will follow strict six feet social distancing guidelines while in the building.

Since 1978, juniors in Elk Grove High School's AP United States history classes have been participating in the "Voice of Democracy" contest. The national essay and speech contest, established in 1947, is sponsored by the Veterans of Foreign Wars and its Ladies Auxiliary, and administered locally by Elk Grove Village Post #9284. TEMPORARY RECORDS of Class of 2016 <u>ALUMNI AVAILABLE</u>

Township High School District 214 will begin destroying the **Class of 2016's**

temporary student records on July 1, 2021, pursuant to the Illinois School Student Records Act and the Local Records Commission. These records may include family background information, teacher comments, disciplinary information, test scores, among other things. Students' **permanent** records are kept for 60 years and include student and parent/guardian names, student birth date, grades, attendance, academic transcript, and scores received on State assessments (9th through 12th grades).

Class of 2016 alumni and their parents/guardians can pick up their respective student records beginning June 1 through June 30, 2021, during the hours of 7:30am-3:30pm Monday through Thursday. <u>Parents/guardians must have a signed</u> <u>statement of consent from the graduate</u>, which includes the graduate's current address and phone number, allowing the school to release the record to the student's parent/guardian. Upon release of student records, parents/guardians must provide valid proof of identification. Records are available at the student services offices of Elk Grove H.S. on the days/times listed above.

FULL IN-PERSON INSTRUCTION APRIL 5, 2021








Virtual - COMMUNITY SERVICE HOURS

- 12. Read children's books and post on YouTube for elementary students to watch.



D214 PARENT INFORMATION

ASBESTOS HAZARD EMERGENCY RESPONSE ACT:

In accordance with the Asbestos Hazard Emergency Act (AHERA) and the Illinois Asbestos Abatement Act (105 ILCS 105/), you are being notified that all District 214 facilities contain various amounts and types of asbestos-containing building materials (ACBM). These materials do not pose any hazard to individuals unless the materials are disturbed.

The District maintains compliance with all applicable governmental and regulatory asbestos rules and regulations. The District also maintains compliance with the Illinois Department of Public Health (IDPH) and Cook County Department of Public Health (CCDPH) guidelines for operations and maintenance activities. The District routinely performs operations and maintenance activities, required inspections, and surveillance activities to verify that the materials are being managed according to IDPH and CCDPH guidelines.

The Building and Grounds Department of each individual facility and the District Operations Department have copies of the AHERA Management Plans that describe the locations of all ACBM. These plans are available for inspection during regular business hours. Contact the Director of Operations for more information at 847-718-7619.

PESTICIDE APPLICATION NOTIFICATION REGISTRY:

All District 214 facilities practice Integrated Pest Management to minimize the use of any pesticides on school grounds. The Structural Pest Control Act (225 ILCS 235/) and the Lawn Care Products Application and Notice Act (415 ILCS 65/) requires public schools to notify parents/guardians and school employees at least 48 hours (two business days) prior to any pesticide applications on school grounds. The term "pesticide" includes insecticides, herbicides, rodenticides, and fungicides. The notification requirement extends to both indoor and outdoor pesticide applications. Excluded from the notification requirement are antimicrobials such as disinfectants, sanitizers or deodorizers, insecticide baits and rodenticide baits.

Dear Parent/Guardian and Staff Members:

In 1999 the Illinois General Assembly passed laws requiring that public schools notify parents/guardians and school employees at least 48 hours prior to any pesticide applications on school property. The term "pesticide" includes insecticides, herbicides, rodenticides, and fungicides. The notification requirement extends to both indoor and outdoor pesticide applications. Excluded from the notification requirement are antimicrobial agents (such as disinfectants, sanitizers, or deodorizers), insecticide baits, and rodenticide baits.

Elk Grove High School has therefore established a registry of people who wish to be notified. To be included in this registry for school year 2019-20, please complete the form below and submit it to the Building and Grounds Supervisor at your school. Dear Parent/Guardian,

Immunization Requirement for the 2020-2021 School Year:

For the 2020-2021 school year, all students entering 12th grade shall show proof of having received two doses of MENINGOCOCCAL CONJUGATE VACCINE (Menactra, Menveo, MCV4) prior to starting school. The first dose should have been administered on or after their 11th birthday and the second dose on or after their 16th birthday. An interval of at least eight weeks between the first and second dose is required. Only one dose of the vaccine is required if the first dose is administered when the child is 16 years of age or older. You do not have to wait until your child is going into 12th grade to get the 2nd dose of meningococcal conjugate vaccine - once your child turns 16 years-old they are eligible to receive it.

Your child may have already received both doses of the required Meningococcal Conjugate Vaccine, however we may not have received proof that they were given. Please check with your child's medical provider to determine if they received the two Meningococcal Conjugate Vaccines and, if they were given, please ask that they complete all information indicated below, including their signature and office stamp. If your child has not received both doses, you are required to get this vaccination for your child or your child will be subject to exclusion as described in the school code of Illinois.

Your child will not be able to receive their class schedule or attend school in August until all immunizations are up to date.

Please submit this completed form or an updated immunization record to the Health Office at Elk Grove High School as soon as possible.

Meningitis Vaccine Requirements:



Please note - all students 16 years of age and older are required to receive a meningococcal vaccine prior to entering 12th grade. If the school health office does not receive proof that your child received the required meningococcal vaccine by the first day of school for the 2021-22 school year, your child can be excluded from school until the appropriate documentation is received by our school health office. Students who have a medical, or other reason, for not receiving the vaccine must provide documentation to the health

office indicating the exception.

Ronald McDonald Medical Van:



Students who do not have medical insurance or who have Medicaid insurance are eligible to participate in the Ronald McDonald Mobile Medical Clinic. This service is sponsored by Advocate Health Care and dates for these clinics are booked throughout the school year at Elk Grove H.S. Upcoming 2021 dates for the

<u>clinic are: March 16, April 1, May 4 and May 13.</u> Due to the Covid-19 pandemic, we are currently booking appointments for vaccines only. At this time, they unable to perform physical exams at Elk Grove High School. Please contact the school health office for further information. Applications are available through the health office or on our Elk Grove High School website under Health Services.

Chronic Health Conditions:

School achievement is dependent upon effectively meeting the health needs of each student. If your student has a chronic health condition such as asthma, severe allergies, diabetes, or a seizure disorder, it is important for the school, medical provider, and family to work together to provide the best educational experience possible.

In an effort to provide your student the opportunity for a successful school year, a number of printable healthcare



plans are available on the Elk Grove High School website under the Health Services tab: <u>https://www.d214.org/Page/265</u>. Care plans are designed to help the school nurse collaborate with your student's medical provider and family to ensure that the child's healthcare needs are met at school. You can print the care plan from the link listed above or contact the school health office to receive a care plan by mail or via email. A new/updated care plan must be completed and turned in at the beginning of each school year, or as soon as possible after the school year begins.

From the School Nurse.....

Students Needing Medication at School:



If your student requires daily or "as needed" medication at school, or if they require an epinephrine injector or inhaler to self-carry or keep in the health office during the school year, we ask that the district medication permission form be completed for each medication needed. This form is located on the Elk Grove H.S. website under Health Services: <u>https://www.d214.org/Page/265</u>. Please sign and date the form and have your child's medical provider complete the section indicated. The form

should then be turned into the school health office along with the medication. All medications provided to the school health office must be in their original container or packaging, or alternatively, the medication must be in an appropriately labeled container from a pharmacy.

Students with Asthma:

Illinois State Law requires that all students diagnosed with Asthma have an <u>Asthma Action Plan</u> on file with their school. An <u>Asthma</u> <u>Action Plan</u> is a plan developed by you and your child's medical provider that provides the school nurse with an individualized plan of care for your student in the event that they experience asthma symptoms at school or at school-sponsored events (such as coughing, wheezing, shortness of breath, chest tightness or difficulty breathing). We encourage you to consult with your child's



medical provider whether or not the child can self-carry their emergency asthma medication at school or if you prefer to keep it with the school nurse. The <u>Medication</u> <u>Permission/Medication Self-Carry Form</u> must be completed and turned in along with the <u>Asthma Action Plan</u>. The links to all of the appropriate forms are listed below. We ask that you print out the forms you need, sign/date them, and have your student's medical provider complete their portion of the form. The completed forms should be returned to the School Nurse at your student's school.

Additionally...It is very important that the school nurse be made aware if your child has a severe allergy to any food, insects, latex, or other allergens. A <u>Severe</u> <u>Allergy Action Plan</u> should be completed by you and your student's medical provider and then be turned in to the Health Office at your student's school as soon as possible.

IMPORTANT HEALTH REQUIREMENTS SCHOOL PHYSICALS FOR INCOMING FRESHMAN (Class of 2025)

- A physical and immunization record <u>MUST</u> be completed by all class of 2025 incoming freshman and submitted to the school nurse preferably by May 29, 2021, or at the absolute latest before the first day of school on August 11, 2021. A copy of the State of Illinois Child Wellness Exam form is included in this newsletter. If you choose to take your child to a local pharmacy or clinic for their physical, you <u>MUST</u> bring a copy of their immunization records with you to that visit for the clinic/pharmacy to review.
- If your child completed a school physical, including immunization records, during 8th grade and the exam is dated August 12, 2020 or after, please get a copy from the Junior High School and provide it to us. This will meet the criteria for entry into 9th grade. **SPORTS PHYSICALS ARE NOT ACCEPTABLE FOR ENTRY INTO 9th GRADE.**
- In order for a school physical to be considered **<u>FULLY COMPLETE</u>**, it must contain all of the following:
 - *On the front side of the form*: Fully completed immunization section with the signature of the medical provider and the date of the exam.
 - On the back side of the form: The health history at the top (parent section) must have all questions answered along with a parent/guardian signature and date. The medical provider must complete the Diabetic Screening and vitals (including blood pressure), height, weight, and BMI of the student along with the "review of systems" section. You also <u>MUST</u> indicate if the child is cleared for P.E. and sports at the bottom of the form.
 - **PLEASE NOTE:** If the medical provider does not include their signature, date of exam, and their medical clinic stamp on the physical, it will be considered invalid.
- If you are turning in your child's Physical Form in person during the summer months, please go to Door 1 (Front Entrance) of the High School and turn it into Student Services or the Main Office. You can also fax the form to the Medical Office at 847-718-4562. If you want to email the physical, please scan the physical, save it as a pdf with your Child's Name and ID#, attach this document to an email to me directly **(photographs of state-required health documents cannot be accepted)**. You can also mail to Elk Grove High School Attention: School Nurse. Elk Grove High School is open during the summer months, Monday through Thursday from 7:00 a.m. to 4:00 p.m.
- District 214 Board of Education enforces a first day exclusion policy. If your child's school physical is not received or fully completed by the first day of school, they will not receive their schedule and may be excluded from starting school until it is received by the health office. Students may also be sent home from school on the first day if a completed and signed Physical and Immunization Form is not received by that date. The student will be marked truant for missing school due to incomplete medical records.
- Please consult with your child's medical provider regarding required vaccines.
- Class Schedules will **NOT** be issued to a student, parent, or guardian until the health office reviews and approves the 9th Grade Physical Form along with the Immunizations list.
- Please contact me if your child has a health condition about which I need to be aware.

- Debe completar un registro del físico y vacunas para estudiantes de noveno grado y entregarlo en la oficina de salud de la escuela antes del 29 de mayo de 2021 o ANTES del primer día de clases el 11 de agosto de 2021. Junto a esta carta le enviamos una copia del formulario del Examen de bienestar infantil del estado de Illinois y una lista de las clínicas a bajo costo del área a las que puede llamar para obtener más información sobre los precios de las vacunas y los exámenes físicos escolares. Si decide llevar a su hijo a una farmacia local para el examen físico de la escuela, DEBE traer una copia de su registro de vacunas a la visita para que la revisen e incluyan en el formulario.

Relationship Science: Connecting Parents and Caregivers with Teens



Perhaps some of us, between the freezing temperatures, endless snow and the pandemic, have found ourselves spending more time together than ever. Yet ... are we closer? Do we know more about each other? Has the quantity of our time together altered the caliber of our relationships?

Jonathan Kanter, PhD., Director of the Center for the Science of Social Connection at the University of Washington, while conducting a COVID-19 Coping Study (where 500 participants were sent relational coping tips through text messaging daily for a month), discovered that going back to relationship basics and social connection is crucial to physical health, mental health, and quality of life.


