This was the day before I received an email letter on August 14, 2020 from Mrs. Marni Johnson not enrolling my Daughter into District 214 for the 2020/2021 school year because of residency. The Arlington Heights Police Department verified my Illinois Drivers License, My Vehicle Registration, My Personal Identification Card with the star, My Son's Illinois Drivers License and my Daughter's Personal Identification Card with a star to our residency in Arlington Heights since August 2017, which is on the Police Computer System. I told the Police that I was having problems registering my Daughter into District 214 and getting frustrated with their responses. The title(s) of each book(s) or other material that was requested to be pulled from your shelves or classrooms, as well as any reason stated by the requester; 3. Any response (email, letters, texts, board proceedings, or notes from phone calls) from anyone in your district, your school board, or individual school, to each request; 4. The resolution of each request (i.e.: the book or material was removed completely; the book or material was partially restricted; the book or material remains on your shelves or in your classrooms; etc.). - Please also provide me with any documented threats that have been received by Township High School District 214, your school board, or any of your individual schools, librarians or teachers, via email, letters, texts, or voicemail recordings, that are related to books or other material kept in one of your libraries or classrooms.
